


**MANAGEMENT CERTIFICATE FOR

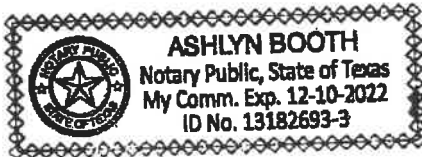
