



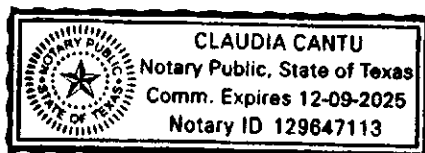
1. The name of the subdivision is Green Tree Country Club Estates.



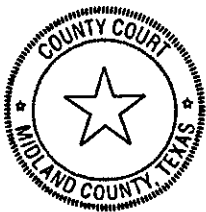
