(for documents that need to be provided in less than 3 business days);

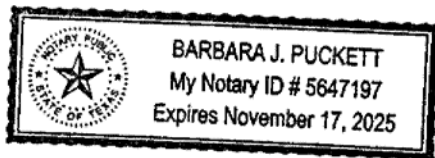
