Upon the purchase of a lot from Declarant, the Capitalization Fee shall be \$275.00, thereafter the Capitalization Fee will be determined by the Board and must be confirmed with the Association.

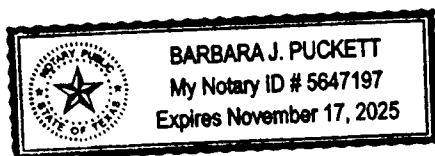
