


**MANAGEMENT CERTIFICATE FOR


- (1) The name of the subdivision is Bristol Forest (the "Subdivision");



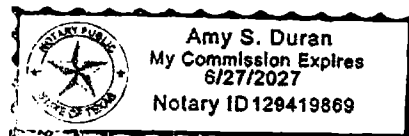
