



- 7. Amount and description of all fees or charges by the association relating to a property transfer: \$375 resale certificate; \$75 resale certificate update; \$30 service fee; compliance inspection fee \$120; \$250 transfer fee (HOA); \$275 transfer fee (management).

Please plan ahead when ordering a resale certificate or update, by law the association has 10 business days to provide the information once the request is received. The resale certificate is a detailed document containing significant amounts of information including lot-specific information, and takes time to domptle. The association has no duty to offer "rush" service. Should the association elected offer "rush" or other expedited resale certificate processing, a fee for performing the service in an accelerated timeframe may be charged. This is a fee not related to transfer of a lot but related to providing a service at an accelerated rate over and above that required by law. Any rush fee will not exceed \$300 for 1-day rush; \$200 for 3-day rush; \$100 for 5-day rush.
