

**1st AMENDED MANAGEMENT CERTIFICATE FOR

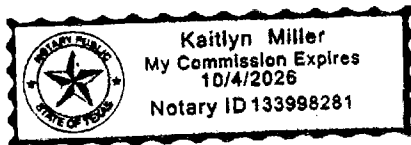
