- (e) RUSH FEE: \$100.00
(for documents that need to be provided in less than 3 business days);
- (f) Capitalization Fee Due at Closing - \$300.00;

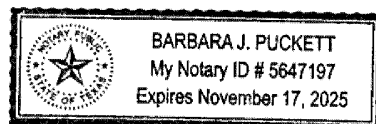
