THAT WHEREAS, the Articles of Incorporation and Bylaws of Eagles Point Homeowners Association, Inc. ("the Association"), Chapter 204 of the Texas Property Code, and the Texas Business Organizations Code authorize the Association to exercise all powers reasonable and necessary for the governance and operation of the Association;

WHEREAS, Section 204.010(a)(10) of the Texas Property Code authorizes the Association to impose "late charges" for late payments of regular assessments;

WHEREAS, the Association's Board of Directors has previously determined that the imposition of a late charge for unpaid regular assessments was/is necessary and proper, and that such action would serve the best interest of the Association and its members. Such Board of Directors voted to implement a late charge of \$10.00 per month, which vote was taken during the HOA monthly meeting of October 2021. The Board hereby formally ratifies such previous vote, as well as all actions taken in connection therewith, including the resultant imposition of monthly late charges for unpaid annual maintenance charges, and does hereby approve the continuation of such monthly late charge.

NOW, THEREFORE, BE IT RESOLVED that the following Schedule of Late Fees for Unpaid Assessments is hereby adopted and in all respects ratified on behalf of the Association:

SCHEDULE OF LATE FEES FOR UNPAID ASSESSMENTS

This Schedule of Fees for Unpaid Assessments (the "Schedule") and the ratification of same by the Association's Board of Directors shall apply retroactively, and proactively. This Schedule shall be effective upon signing, and shall thereafter be recorded in the Official Public Records of Real Property of Galveston County, Texas.

Unpaid Annual Assessments – Late Fees

Annual assessments are due on or before January 1st of each successive calendar year. A 30-day grace period (until January 31st) is automatically granted to all Members. During this grace period, late charges shall not accrue against an account, unless a delinquency exists from a previous year.

As of February 1, owners who have not fully paid any outstanding assessment shall be assessed a late charge in the amount of \$10.00. An identical late charge shall be assessed on the first day of each successive calendar month until all outstanding assessments have been paid. All late charges shall be in addition to annual / monthly accrued interest charges for unpaid assessments. Late charge shall be suspended during the term of any payment plan agreement entered into between the Association and a delinquent owner. The Board may require that payment plan agreements be reduced to writing, in conjunction with the Association's recorded Collection Policy, and subsequent amendments and/or supplements thereto.
