

- f. **Mandatory New Owner Packet fee** not to exceed \$150.00.

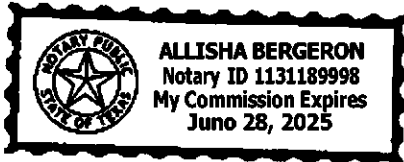


