A written request which does not specify the name and location to which the information is to be sent is not effective.

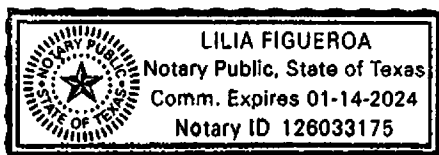
