- 3. Recording data for subdivision: The subdivision consists of three tracts of land located in the Town of Flower Mound. The Association charges a \$275 fee for a newly-issued resale certificate and \$75 for an update to a recently-issued resale certificate.

The purpose of this Property Owners' Association Management Certificate is to provide information sufficient for a title company to correctly identify the subdivision and to contact its governing association. This Management Certificate does not purport to identify every publicly recorded document affecting the subdivision, or to report every piece of information pertinent to the subdivision. No person should rely on this Management Certificate for anything other than instructions for contacting the association and fees charged for a resale certificate.
