

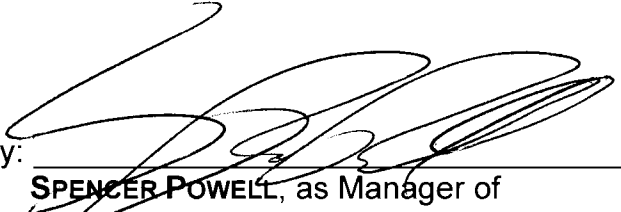
**MANAGEMENT CERTIFICATE FOR

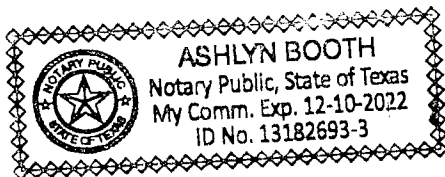

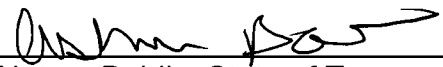
