


**MANAGEMENT CERTIFICATE FOR



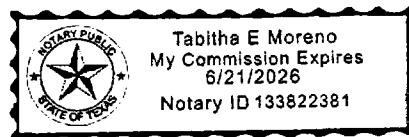

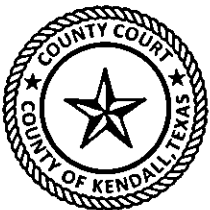
