

The Road Maintenance Association's annual meeting immediately followed the HOA meeting. RMA President J.T. Johnston opened the meeting at 2:45 pm.

Members present included: John & Greta Spradling and J.T. Johnston. Guest present were Paul Cravey, renter of lots 15 & 16 and J.T.'s sister-in-law. The minutes from the previous meeting were attached to the HOA minutes. No changes were made.

Secretary/Treasurer Report: The secretary reported on the American Bank balance as of 8/31/2021 was \$5,242.33. All bills have been paid to include Taxes and Klean Kuts Mowing. Total amount of dues collected as of the meeting was \$800.00. There are five lots that have not paid dues and have outstanding mowing charges. (Same report from HOA meeting.)

Old Business: The RMA continues to hire mowing for the absentee owners and bill at the time dues notes are mailed. Paul Cravey hires and pays for mowing on each occasion for Lot #16.

J.T. Johnston provided an update on the 12-inch, natural gas pipeline currently being installed in the community. Kyle Bay is the Contractor. The line crosses lots 1, 2, 3, 4, 5, and 16. The ENOS MURPHY Survey A-647 was shared with the members present. Where the line crosses roads, buildings, trees (valued at \$80,000 by arborist), and swimming pools, the company will dig underground to not interfere with surface property.

The RMA will evaluate the road condition for repair following the pipeline installation. The pipeline company will be expected to pay for all expenses. The RMA President, on behalf of the RMA, will remain in contact and follow up on actions necessary.

New Business: Delivery of rock for County Road 1157 will be delayed until the pipeline work is complete. Currently, no river rock is available to maintain the road.

The next mowing will be in October. It should be the final mowing for the year.



New Business: Road repair is needed for the curve in the road at the Southwest corner. Quotes are needed on the contractor work to complete the repairs.





John and J.T. will continue to monitor the neighborhood entrance, Highway 903 and CR 1157. They will discuss and get estimates for contracting repair.


